## II. ROMANIAN INSTITUTE FOR HUMAN RIGHTS ANNUAL REPORT – 2014

The Romanian Institute for Human Rights (RIHR), an independent body with legal personality, established under Law No. 9/1991, is the first national human rights institution created in Romania after 1989 and the only institution in our country to have been acknowledged as such by the International Coordinating Committee of National Human Rights Institutions in the United Nations system.<sup>1</sup> In addition to its capacity as member of the European Network of National Human Rights Institutions, the Institute is also member of the Association of Francophone Human Rights Commissions, member of the European Law Institute of Vienna, alongside the High Court of Cassation and Justice, and member of the International Institute of Law of French Expression and Inspiration.

The Romanian Institute for Human Rights complies with the Paris Principles set up in 1991 at the Conference devoted to National Human Rights Institutions, which became an official document of the United Nations General Assembly in 1993 and refer to: an "as broad as possible" mandate, based on the universal standards of human rights, including the double responsibility to promote and to protect human rights, while covering all the rights; adequate power of investigation; pluralism, including the effective structure of its staff and/or cooperation; and adequate human and financial resources. At the same time, the Institute also complies with the requirements set forth by the Council of Europe in its Recommendations R (79) 16 and (97) and Resolution (97) 11 by the Council of Europe Committee of Ministers.

Focusing its preoccupations on the actual realities of each time period, each stage, the Institute had permanently in mind the organization of an adequate framework and the creation of adequate means for the effective application and observance of human rights, for better familiarization with and awareness of these rights, both by public institutions and by natural persons, so much more so that Romania is a member country of the UNO, the OSCE, the Council of Europe and the European Union.

Under the circumstances, the Institute focused its activity laying particular emphasis on programmes and partnerships that best fit the international and the national requirements concerning the promotion of human rights and fundamental freedoms, the training of persons responsible for the protection thereof.

Collaboration with governmental and non-governmental bodies with powers in the field of human rights and the experience accumulated in time were particularly important for the Institute in its efforts to fulfill the powers conferred by Law No. 9/1991, in its capacity as national independent institution promoting human rights, to act as an interface, a bridge between these public institutions and the civil society.

Aware of the particular importance of being familiar with human rights, in the year 2014, the Romanian Institute for Human Rights continued training. informing, its documenting. researching and advising activities contributing, by its entire work, to the training of persons in the public structures and institutions with such powers as protect and promote human rights, systematically inform the citizens about the rights guaranteed by the legislation or laid down in the international documents where Romania is a party. In this respect, in 2014 the Institute organized a large number of scientific events, symposia. seminars. roundtables. debates. training courses, exchanges of experience, etc. The Institute made researches, published and disseminated works and reports in the field in an attempt to contribute to better understanding of the international standards, the instruments and mechanisms for the international protection and promotion of human rights where Romania is a party, so that they should be fast and correctly applied at national level.

When the Institute's Programme of Activities for the year 2014 was developed, such documents were taken into account as the Paris Principles relating to the status of national institutions for the promotion and the protection of human rights, the Declaration of Durban, the Programme of Action of the World Conference on Human Rights – Vienna, the Action Plan of

the Council of Europe Steering Committee for Human Rights, General Assembly Resolution 59/113 on the World Programme for Human Rights Education for the period 2005-2009 and the second phase of the Action Plan for the 2010-2014, the United period Nations Millennium Objectives, the United Nations Objectives for the year 2015, Human Rights Council Resolution 21/14 on the World Programme for Human Rights Education, the European Union Agency for Fundamental Rights Strategy and Multi-Annual Programme 2013-2017, as well as the main objectives established by the European Commission to be attained by 2020 under the "Europe 2020" Strategy, which became national objectives for each EU member country (employment, research and development / innovation, climate change / energy, education, and poverty / social exclusion), the European Strategy for equality between women and men (2010-2015), the European Commission's European Disability Strategy (2010-2020), the Action Plan of the European Network of National Human Rights Institutions (2014-2016).

To accomplish its task of promoting and disseminating human rights, the Romanian Institute for Human Rights concluded new partnerships and continued the old ones with governmental and non-governmental institutions and bodies, both domestic and international.

Synthesizing the activities performed by the Romanian Institute for Human Rights in the year 2014, they could be grouped into the following directions:

• Achieving better knowledge of human

• rights issues and how these rights are guaranteed in the member countries of the UN, the OSCE, the Council of Europe and the European Union;

• Informing international institutions about the practical ways human rights are promoted and guaranteed in Romania;

• Making researches in relation to new human rights, such as the right to happiness, new violations of human rights or important aspects in the field of promoting and observing human rights in our country and at international level;

• Organizing conferences, seminars, international symposia in collaboration with the parliamentary commissions and universities;

• Organizing and achieving training and educational programmes in the field of human rights and finding new methods and methodologies;

• Promoting fields of interest, on initiative by the United Nations or other international or regional organizations (for instance: business and human rights), joining various activities on proposal by the European Union Agency for Fundamental Rights (Project CLARITY, or projects related to the rights of persons with disabilities, migrants, women, children, domestic violence, etc.);

• Editorial activities;

• Publishing recently released international and national regulations, documents, studies and researches in the field of human rights;

• Improving the activity of the Institute's Documentation Center;

• Providing advisory opinions.

## I. RESEARCHES DEVOTED TO THE PROMOTION AND THE OBSERVANCE OF HUMAN RIGHTS IN ROMANIA AND AT INTERNATIONAL LEVEL

Investigation of the various aspects related to the promotion and the observance of human rights is one of the main elements of the Institute's activity. In the approach to this activity, provided by the law, the Institute had in view the "Paris Principles"<sup>2</sup> on the status of

National Human Rights Institutions, the Programme of Action of the World Conference on Human Rights of Vienna (1993), the United Nations Millennium Objectives, the United Nations Objectives for the year 2015, the Declaration of Durban (2001), the Action Plan of the Council of Europe Steering Committee for Human Rights, United Nations Resolution 59/113, the Annual Programme of the European Union Agency for Fundamental Rights, the European Commission's European Disability

Strategy (2010-2020), the European Strategy for equality between women and men (2010-2015), as well as Recommendations R (79) 16 and (97) 14 and Resolution (97) 11 by the Council of Europe Committee of Ministers, which proves that the investigation of human rights and the learning of human rights are adequate means for respecting human dignity and provide increased respect for human rights through better familiarization with these rights.

Aware of its mission to contribute to the establishment of a culture of human rights in our country, the Institute elaborated researches presenting general aspects related to the history and the evolution of human rights at levels. international and domestic the philosophy of human rights, the science of human rights, codification in the field of human rights, as well as special fields related to the various generations of human rights. Thus, the researches dealt with both the first generation rights – the civil and political rights, and the second generation rights - the economic, social and cultural rights. The topics dealt with also included third generation human rights, such as the right to peace, the right to sustainable development, right to healthy the а environment. At the same time, new topics were also dealt with, such as the right to happiness as a fundamental human rights (according to the United Nations General Assembly Resolution 65/309/2011) or business and human rights (according to the UN "Protect, Respect and Remedy" Framework and the implementation document of 2008 - DOC A/HRC/8/5), annual researches on human rights in EU and the legislation of Romania, the comparative study of human rights in the annual reports of the European Union Agency for Fundamental Rights.

The accumulated experience and the professional training of the Institute's researchers, as well as of its voluntary collaborators - researchers, personalities of the scientific community or young researchers made it possible to approach recent issues in the field, through extensive papers, extending over more than one year and achieved by teams made up of in-house researchers who worked in partnership with associated voluntary researchers, which allowed for thorough studies dealing with vast, important topics. At the same

time, there were research works devoted to specialized fields, usually achieved by one author. The results of these studies were made available by publication in either the Institute's quarterly "Drepturile Omului", the monthly Info IRDO, volumes or in reports presented at the scientific events organized by the Romanian Institute for Human Rights and/or by various national and international bodies with which the Institute has been collaborating. The great majority of the studies and research works achieved in the framework or with the participation of the Romanian Institute for Human Rights fall into this category.

The researches achieved in the year 2014 were based on the national legislation in the field of human rights and the international and the regional documents that have become part of the domestic legislation as a result of their ratification by Romania. In this respect, the documents referred to by the Institute's studies and reports include, among others: the United Nations Charter; the Universal Declaration of Human Rights (Romania signed it in 1955, when it became a Member State of the United Nations Organization); the International Covenant on Civil and Political Rights (ratified by Romania in 1974); the International Covenant on Economic, Social and Cultural Rights (ratified by Romania in 1974); the Optional Protocol to the International Covenant on Civil and Political Rights (ratified by Romania in 1993); the International Convention on the Elimination of All Forms of Racial Discrimination (ratified by Romania in 1970); the International Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (ratified by Romania in 1990); the Convention on the Elimination of All Forms of Discrimination Against Women (ratified by Romania in 1981); the Convention on the Rights of the Child (ratified by Romania in 1990); the Convention on the Rights of Persons with Disabilities (ratified by Romania in 2011); the European Convention on Human Rights (ratified by Romania in 1994); the European Social Charter revised (ratified by Romania in 1999); the European Convention on Action against Trafficking in Human Beings (ratified by Romania in 2006); the European Convention for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (ratified by

Romania in 1994); the Framework Convention for the Protection of National Minorities (ratified by Romania in 1995), as well as others.

## In terms of the topics dealt with, one may distinguish:

a) researches dealing with a general topic;

b) researches devoted to the instruments and mechanisms for the protection of human rights and their evolution in time;

c) researches related to the protection and the promotion of human rights;

d) researches referring to fundamental freedoms and human rights of the three generations: the civil and political rights; the economic, social and cultural rights; the right to peace, the right to sustainable development and the right to a healthy environment.

An illustrative presentation of each category of researches proves the diversity of the approached topics.

#### a) <u>Researches dealing with a general topic:</u>

- Promotion of a culture of human rights;

- Human rights in the documents of the United Nations Organization;

- Disability – a human rights issue;

- Multiple discrimination and fighting against it;

- Evolution of the juridical academic education at European level;

- Health – a human rights issue;

- Evolution of the secretary general institution in the parliamentary system.

#### b) <u>Researches devoted to the instruments</u> and mechanisms for the protection and the promotion of human rights and their evolution in time:

- Issues related to migration and the law in Romania's legislation;

- Freedom of conscience and freedom of expression in the Constitution of Romania;

- Religion-related provisions applicable in Romania according to the national legislation;

- Special techniques of criminal supervision or criminal investigation and the importance of observing the rights and the fundamental freedoms;

- Immigration and the integration of migrants. The Member State responsible for the examination of an international protection application and the effective access to a procedure in the European Union;

- Regularization of the lawsuit application – a key element for free access to justice;

- Aspects from the jurisprudence of the European Court of Human Rights related to free access to justice;

- Aspects related to the regulation of the status of the permanent public servants in the EU Member States.

#### c) <u>Researches related to the protection and</u> the promotion of human rights:

- Promotion and protection of the fundamental rights in the European Union;

- Promotion and protection of human rights by the legislative authority;

- The role of jurisprudence in the unitary application of the law;

- Execution of the decisions of the European Court of Human Rights;

- Aspects related to the regulation of the rights of the child in Romania;

- Freedom of conscience the religion classes in schools;

- Human rights in correlation with the absorption of the European funds;

- Policies related to the rights and freedoms of persons with disabilities.

#### d) <u>Researches devoted to the fundamental</u> freedoms and human rights: civil and political; economic, social and cultural; the right to peace, the right to sustainable development, the right to a healthy environment:

- Issues related to the acknowledgement of the legal capacity of persons with disabilities;

- Issues related to the participation of persons with disabilities in sportive activities;

- Evolution of the economic and cultural rights after 15 years since ratification of the European Social Charter revised;

- The economic crisis and the economic human rights in Romania;

- The right of persons with disabilities to an independent life and integration within the community;

- Orientations of the public health system reform in Romania;

- The right to sustainable development;

- The right to a healthy environment in light of UN Post-2015 Development Agenda;

- Re-interpretation of the right to peace.

# II. TRAINING PROGRAMMES AND EDUCATIONAL ACTIVITIES IN THE FIELD OF HUMAN RIGHTS

As former Director General of UNESCO, Federico Mayor, said "Human rights education is a never-ending task, which has to be renewed from one generation to the next. This does not make it a labour of Sisyphus, though. The history of recent decades makes it quite clear that, if tended and shielded, the seed of human rights will ultimately germinate, albeit in a chill wind and on stony ground".

The activities performed in the field of education and trainers' training (see **Appendix A**) targeted one of the main objectives provided by the Law on the establishment of the Romanian Institute for Human Rights: organization of training programs, particularly addressing those categories of persons having special responsibilities for the protection of human rights or to ensure awareness of human rights issues amongst large categories of the population.

Taking account United into Nations Resolution 59/113 of 10 December 2004, which instituted the World Programme for Human Rights Education for the years 2005-2015, the Romanian Institute for Human Rights acted in conformity with this Resolution and in the year 2014 took particular interest in intensifying and diversifying the activities devoted to education. The aim pursued was to train those civic attitudes and behaviour characteristic of a democratic society and to increase interest in and competencies of participation in the public life of an as large as possible number of citizens from all socio-professional categories, both young and old.

In order to continuously adapt its activities, the RIHR included in its Plan of Action the following objectives, among others:

• Promote human rights education;

• Make human rights education a priority at national, regional and international levels;

• Train adults and youngsters in relation to human rights and the rights of the child;

• Train trainers in the field of human rights;

• Train educators – teachers in the pre-university and university educational units;

• Train certain professional categories that are directly involved and have responsibilities in the promotion and the defence of human rights and the rights of the child;

• Consolidate partnership and cooperation with the institutions belonging to the Romanian educational system as well as other institutions, associations, NGOs in various fields;

• Monitor and assist educational programmes existing in the field of human rights, point out good practices and stimulate measures meant to continue, improve and develop those practices.

The activities devoted to the training of trainers and human rights education were conceived and organized based on the feedback received from representatives of the Teacher Training Centers and teachers from various schools and high schools.

The groups targeted by the activities organized by the Training Department of the RIHR included persons in such fields as education, research, public administration, justice, health, as well as persons belonging to categories with special problems: women, children, pensioners, minorities, persons with disabilities, etc.

The Institute's training activities were initiated by the Institute itself, by partners, on request by the central and the local authorities or by certain socio-professional groups and took various forms:

- long-term training courses, accredited by the Ministry of Education and Scientific Research;

- short-term "contact" type training courses;

- activities meant to raise awareness of certain social groups about the need to know and respect human rights and the rights of the child;

- symposia, conferences, seminars, roundtables, debates, etc;

- dissemination activities;

- presentations of books published by the RIHR.

Important activities were achieved in the year 2014 together with old and new partners from among non-governmental organizations mainly interested in the field of human rights education, with public institutions and also institutions belonging to the higher education system, religious denominations, professional associations, etc.

The first to be mentioned out of the educational and training activities are the continued scientific events that have been enjoying popularity at national level and are also known at international level:

• The 20<sup>th</sup> edition of the summer courses of the *International University of Human Rights*, organized by the Romanian Institute for Human Rights in partnership with the UNESCO Chair for Human Rights, Democracy, Peace and Tolerance, the Romanian Association for the United Nations and the the "Victor Dan Zlătescu" Club of Cheia;

• Debates, training courses, roundtables, seminars, conferences, book releases, etc., organized in collaboration with other institutions and non-governmental organizations (see **Appendix A**);

• Coordination of the UNESCO Chair for Rights, Democracy, Peace and Human Tolerance by the RIHR and the North University of Baia Mare, a permanent activity that also includes the Master Degree courses, the only ones of the kind in Romania (a new class of Masters graduated in 2014), debates, training courses, roundtables. seminars. conferences, book releases, etc., organized in institutions collaboration with other and non-governmental organizations (see Appendix **A**);

• The 20<sup>th</sup> edition of students' national contests "*The Civic Education and Civic Action Olympics*" and "*Democracy and Tolerance*", respectively;

• Debates, symposia, colloquia devoted to the promotion of human rights in various fields (see **Appendix A**), etc.

1. Education of the younger generation in the spirit of respect for fundamental freedoms and human rights, for dignity and tolerance, for free exchange of opinions is an objective that has been object of a partnership between the Romanian Institute for Human Rights and the Ministry of Education and Scientific Research, materialized in the form of several activities that have become traditional: the national school contests "The Civic Education and Civic Action Olympics" and "Democracy and Tolerance", continuous training courses for teachers and primary school teachers; colloquia, symposia and debates (see **Appendix A**) on topics related to various aspects of the human rights education activity and, last but not least, the *Didactic Creativity Contest on achieving auxiliary materials to be used in human rights education* and a *National Contest on literary creation and plastic creation for primary school students.* 

## 2. National school contests

As result of an initiative by the Romanian Institute for Human Rights, in 1994, the Ministry of Education and Scientific Research included disciplines *civic education* (grades III-IV) and *civic culture* (grades VII-VIII) into the category of those disciplines for which annual contests are organized, with stages up to national level.

These contests, organized by the Romanian Institute for Human Rights in partnership with the Ministry of Education and Scientific Research, also known under the name of "Olympics", respond to the need for education meant to shape the role and the status of citizens of a democratic society, to train and develop competencies for participation in the public life, a social critical spirit and tolerance capacity.

## a) The National Olympics on social human sciences

The concept of fundamental freedoms and human rights originates in people's need and desire for a life where everyone's dignity and value should be respected and protected. In this respect, the final stage of the National Olympics on social human sciences was organized in April 2014 in Timişoara by the Romanian Institute for Human Rights in partnership with the Ministry of Education and Scientific Research. This is an excellence contest addressing students with skills in the field of social human sciences, which responds to the need for education meant to shape the role and the status of citizens of a democratic society, to train and develop competencies for participation in the public life, a social critical spirit and tolerance capacity. The contest disciplines are: civic education, civic culture, logics, psychology, sociology, economy and philosophy. The students participating in the civic education contest are organized in teams made up of two students from the III or the IV grade, while those

participating in the civic culture contest are organized in two-student teams as well, but the students are VII or VIII grade students of the same school. The Vice-President of the Civic Education and Civic Culture Sub-commission is the Head of the Training of Specialists Department of the RIHR.

As usual, at the 2014 edition the best papers achieved by the participating teams were awarded diplomas and prizes by the Romanian Institute for Human Rights.

## **b)** The 20<sup>th</sup> edition of the final stage of the "Democracy and Tolerance" National Contest

The contest initiated by the Romanian Institute for Human Rights in partnership with the Ministry of Education and Scientific Research is a complex form of civic education involving students in primary and secondary schools. The general objectives of the contest refer to assuming the role and the status of citizens in democratic society, training and developing a constructive civic spirit. In an explicit manner, the contest purposes are: familiarization with such concepts as democracy, tolerance, human rights, rights of the child; familiarization with the national and the international regulations referring to these concepts; give the students the opportunity to practise democratic. tolerant attitudes. behaviour and a civic spirit; train and develop to participate in the educational skills community's life; nourish motivation for the promotion and the defence of human rights and the rights of the child. The contest was organized in three main dimensions: а theoretical dimension (consisting of written practical-applicative dimension paper). а (elaboration of a project meant to solve a problem of the school or the community to which the students belonged, the project having the form of a portfolio), and an artistic dimension (achievement of a plastic art work drawing, graphics, painting, collage, sculpture, etc., illustrating how the problem presented in the project prepared for the practical-applicative test was solved), with teams made up of three students, one of which from a primary school grade. The experience accumulated with the contest reveals constant qualitative improvement of the materials presented, in all its three dimensions, as well as increased

interest in the issues involved. The president of the "Democracy and Tolerance" National Contest Central Commission was the representative of the RIHR. Evaluation of the theoretical papers, the portfolios and the plastic art works was made by three separate sub-commissions made up of specialized teachers, while the president of the Central Commission was the Head of the Training of specialists department of the RIHR.

The contest, whose 2014 edition was organized in Oradea, aimed to develop cooperation competencies at group level, while stimulating interest in the promotion and the observance of human rights. Based upon a system of universal values asserting human dignity and equality, human rights education is absolutely necessary in a democratic society. This should be a responsibility not just of governments but also for each individual within a society. Once the results of the three contest tests were established, the Romanian Institute for Human Rights awarded the "Human Rights" special prizes and honourable mentions.

## c) The 7<sup>th</sup> edition of the National Contest on didactic creativity in the field of auxiliary materials devoted to education for human rights, democracy and a culture of peace in the pre-university educational system

The contest is organized every two years by the Romanian Institute for Human Rights in partnership with the Ministry of Education and Scientific Research and Teachers' Training Centres, and enjoys large popularity amongst teachers from all over the country. It is also worth mentioning the increased interest shown by some Teachers' Training Centres for organizing future editions of the contest.

The Institute's partners for the organization of the 4<sup>th</sup> edition of the contest were the Ministry of Education and Scientific Research and the Teachers' Training Centre of Cluj. The Contest Exhibition exhibited works from several counties, auxiliary didactic materials devoted to the activity with the students, printed works, reviews, CDs, etc.

The exhibits included works achieved by teachers from such counties as Arad, Bacău, Bistrița-Năsăud, Botoşani, Caraş-Severin, Cluj, Constanța, Dâmbovița, Hunedoara, Mureş and Bucharest, which were all appraised as beneficent and constructive, in the spirit of education for human rights, democracy and a culture of peace, an obvious indication of the permanent preoccupation for the free expression of human rights.

Human rights education has a key role in any educational process. In this process, the teachers' role is evident: by the efforts they take and the passion that drives them, they assist their students to become responsible and active citizens, capable and ready to contribute to the creation of a harmonious environment in the society they live in. Moreover, the educational process is based on the active participation of the children, who learn about human rights and come to understand the issues of this phenomenon, while acquiring and developing attitudes of respect for human dignity.

The best works were awarded diplomas by the Romanian Institute for Human Rights and the Ministry of Education and Scientific Research. The organizers also made available a catalogue of the works participating in the contest.

3. As far as the continuous training of pre-university teachers achieving human rights education is concerned, in the year 2014, the Romanian Institute for Human Rights in partnership with the Teachers' Training Centre of Bucharest continued the Training Programme "Education for Human Rights and the Rights of the Child", accredited by the Ministry of Education and Scientific Research. The target public of the Programme consists of teachers and auxiliary personnel in the pre-university educational system.

Created as a result of a large number of requests by teachers training in the field of human rights, in future the Programme will assist students in the process familiarization with and increasing awareness about human rights and the rights of the child, and also the national and the international legislation in the field.

## 4. Activities devoted to the training of practitioners and public servants

The courses of the *International University* of *Human Rights* are an opportunity to bring together specialists and experts with the purpose of renewing and improving the training programmes in the field of human rights; the courses were attended by magistrates, university teachers, representatives of public institutions, experts and specialists in human rights.

The Institute's role in the promotion of the Charter of Fundamental Rights of the European Union as well as the other universal and regional human rights instruments where Romania is a party was pointed out by Mr. Morten Kjaerum, Director General of the European Union Agency for Fundamental Rights. In his address at the international "The EU Conference on Charter of Fundamental Rights: Assessing and Responding to the Training Needs of Legal Practitioners and Public Officials", the section devoted to the role of national human rights institutions and equality bodies in training in the field of human rights, he particularly emphasized the annual training courses of the International University of Human Rights, which bring together practitioners, public servants and scientific researchers.

## 5. Other specific forms of training and education in the field of human rights:

a) Elaboration of special programmes devoted to important events and appreciated as such by the United Nations Organization, the Council of Europe, the Organization for Security and Cooperation in Europe, etc., with resonance for the protection and the promotion of human rights, such as:

- the UN Decade of Education for Sustainable Development (2005-2015);

- the 64<sup>th</sup> anniversary of the European Convention on the Defence of Human Rights and Fundamental Freedoms;

- the 20<sup>th</sup> anniversary of Romania's ratification of the European Convention on the Defence of Human Rights and Fundamental Freedoms;

- 48 years since the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights came into force;

- the 59<sup>th</sup> anniversary of Romania's accession to the United Nations Organization;

- the 40<sup>th</sup> anniversary of the OSCE;

- 2014 – Year of Reconciling Work and Family Life in Europe.

### b) Coordination of the UNESCO Chair for Human Rights, Democracy, Peace and Tolerance.

The Chair was established and functions based on an agreement between the United Nations Educational, Scientific, and Cultural Organization - Paris and the Romanian Institute for Human Rights and the North University of Baia Mare. It is a pilot centre of research, debate and training at post-university level. In the year 2014, a new class of students obtained their Master Degree in human rights, democracy, and tolerance; this training peace form assimilates the results of national and international research, while keeping pace with the progress and the developments in its specific field. It should be mentioned that the Institute is the first national institution to coordinate, in the system of UNESCO partnership programmes, the activity of a Chair for Human Rights, Democracy, Peace and Tolerance.

c) Organization of training courses and participation in debates on various aspects related to the observance and the promotion of human rights in the framework of scientific events, symposia, colloquia, debates, roundtables, etc., or in the media (see Appendix B)

In fulfilling its mandate, the Institute took efforts to attract public institutions and non-governmental organizations by means of partnerships in the field of human rights. The year 2014 was no exception to this policy and so a number of partnerships were concluded or renewed, with remarkable results in terms of the activities performed. Of these, it is worth mentioning:

• Conference on "The right to citizenship in Romania: history, practice, legislation and ethics", organized in collaboration with the Romanian Association for the United Nations and the UNESCO Chair for Human Rights, Democracy, Peace and Tolerance with the purpose of promoting and develop the Romanian society on the basis of respect for the fundamental rights and freedoms that derive from the Romanian citizenship. The event provided training for practitioners, to enrich their knowledge about and understanding of the rights and the duties deriving from the status of citizen of this country;

• Seminar devoted to the International Holocaust Remembrance Day whose objective was the recommendation of training programmes on the lessons be learned from the genocide to convey to future generations a clear message about the importance of promoting and protecting human rights. Based on a universal system of values that asserts human dignity and equality, human rights education is absolutely necessary in a democratic society. This should be a responsibility not just of governments but also for each individual within a society. There is a lot of everyday talk about human rights, yet most people have only a vague understanding of their importance. Reality has shown that there are even less people who take a genuine interest in these rights or are aware that each one of us has duties as well. One of these duties of ours is to learn from the mistakes of the past so as not to repeat them in future. The event was organized in collaboration with the Ecological University of Bucharest, the UNESCO Chair and ANUROM:

• Conference on "European mechanisms for the protection of human rights" organized together with the Ecological University -Faculty of Law and Administrative Sciences and National School Political the of and Administrative Studies - Faculty of Public Administration. The European norms and standards as well as the jurisprudence of the European Court of Human Rights is one of the Institute's permanent preoccupations. A number of debates focused the civil society's attention on the observance of the European Convention and the application in Romania of the decisions pronounced by the European Court of Human Rights. At the same time, the RIHR made available for those interested a number of documents and books in the field, gathered in its capacity as depository library of the Council of Europe;

• Seminar devoted to the "International Mother Language Day", whose topic for the year 2014 selected by UNESCO was "Local Languages for Global Citizenship: Spotlight on Science", organized by the UNESCO Chair for Rights, Human Democracy, Peace and Tolerance, the National School of Political and Administrative Studies and the Romanian Association for the United Nations. The discussions focused role of on the

multilingualism, the impact it has upon intercultural dialogue, social cohesion and prosperity and the importance of lifelong learning;

• Training course on "Non-discrimination and equality of opportunities", organized in partnership with the National School of Political and Administrative Studies - Faculty of Public Administration, a course whose purpose was to make young students and MA students aware about the efforts the European Union takes to combat discrimination and promote equality of opportunities. The course was also organized as a result of a contemporary challenge, that is, the insufficient awareness of the public, particularly the youth, about the rights they have and the importance of reporting any case of discrimination;

• The training course on "Consecration and guarantee of the fundamental human right to a healthy environment" responded to an absolute need in terms of social development. Reality has shown that lack of education is closely connected to a healthy and civilized life. The precarious social wealth and ignorance of some families led to school abandonment. Promotion of the right to a healthy environment is a noble purpose and a responsibility as well. Campaigns against the consumption of alcohol, tobacco, drugs should be a permanent preoccupation;

• The training course on "Institutions and legal instruments specially devoted to migration and asylum", organized in partnership with the NSPAS – Faculty of Public Administration, the EUB – Faculty of Law and Administrative Sciences and the UNESCO Chair, was intended to familiarize the students with the migration phenomenon, which is quite hot in the context of globalization, to make the students understand the humanitarian nature, the need to accept migrants and get involved to help people who migrate for various reasons;

• Conference on "The human rights protection system instituted by the European Convention – 20 years since Romania's ratification of the European Convention on the Defence of Human Rights and Fundamental Freedoms, organized by the Chamber of Deputies Judicial, Discipline and Immunities Commission, Sub-commission monitoring the European Court's decisions pronounced against Romania. At the same time, the RIHR made

available for those interested a number of documents and books in the field, gathered in its capacity as depository library of the Council of Europe. A number of debates focused the civil society's attention on the observance of the European Convention and the application in Romania of the decisions pronounced by the European Court of Human Rights. Also, the of human rights protection promotion instruments and mechanisms was an important educational item with the and training-for-trainers activities<sup>3</sup>:

• The training course on "Rights and facilities for persons with disabilities in Romania", organized in collaboration with ANUROM, pursued promotion of the rights of persons with disabilities among the youth. The course laid emphasis on the guarantees for effective implementation of the Convention on the Rights of Persons with Disabilities, as well as presentation of the European Disability Strategy 2010-2020: A Renewed Commitment to a Barrier-Free Europe;

• Training course on "The United Nations Week", at "Constantin Angelescu" Gymnasium School of Constanta, on 27 October 2014. The training courses were intended to motivate the youth increase their awareness about their rights, as well as the fact that, beside rights, they also have duties and become active in a democratic society where human rights are observed and protected. During the debates, students were encouraged to express their opinions and were offered volumes published by the RIHR. Human rights education should be an integrated component of any educational undertaking, and this event was one of many others entered in the 2014 Action Plan on training and education in the field of human rights. The purpose pursued was to make the young students get actively involved, offer their talent and energy to assist others and thus contribute to the development of our country's society. The participants decided Gymnasium School "Constantin Angelescu" together with other educational units in the county of Constanța should organize additional events meant to develop the youth's respect for human

values;

• Training course on "Children's rights and for dummies", organized by duties the Romanian Institute for Human Rights in collaboration with "Marcela Peneş" Gymnasium School. The event was attended by students from the Students' Council, teachers from the respective school, representatives of the School Inspectorate and representatives of the National Commission of Romania for UNESCO. The course promoted respect for human rights among the students, provided an optimum level of information, adequate to the students' age, on the importance of human rights and the need to respect and protect the fundamental rights and freedoms. The organizers wanted the event to be a "window of opportunity" to strengthen respect for the human being and human dignity, encourage positive behaviours, make the students acquire knowledge and correct skills likely to lead to a correct attitude based on respect for human and spiritual values;

• Conference on "Human rights - 365 Days", organized at Parliament House by the Romanian Institute for Human Rights (RIHR) together with the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies, to mark the International Human Rights Day. Every year, on December 10, the international community celebrates Human Rights Day. The importance of this day is that the UN General Assembly proclaimed that all human beings are equal in rights and these rights should be protected by the State in which these people live their life. Romania has signed the Universal Declaration of Human Rights and celebrates Human Rights Day together with the other signatory States. A delegation of the National Association of the Deaf in Romania (ANSR), who participated in the debates, presented the participants the views of the National Council of the ANSR on the international instrument for monitoring the implementation of the UN Convention on the Rights of Persons with Disabilities;

• The International Conference on "The European culture of human rights – the right to happiness", organized in partnership with "Dimitrie Cantemir" University of Bucharest,

the International Institute for Human Rights and the Academy of Romania on 11-13 December 2014, had the following objectives: a theoretical and philosophical foundation of the right to happiness as a constitutional right; the culture of happiness in a non-equal world; equality of opportunities; tolerance and social solidarity; social happiness as a result of human solidarity; stimulation of interest to get involved with the respect for human rights and the fundamental freedoms in a society committed to respect each individual's dignity and personality: development o the capacity to know and understand the role of the law as norm-creating factor of social behaviour. The event was also an opportunity to scrutinize the level of pupils' and students' awareness about their rights and duties, as well as that of the teachers; it was also an opportunity to increase the awareness the youth and adult persons about the need to respect human rights and their correlative duties;

Training course on "Education on human rights and the rights of the child", organized by the Romanian Institute for Human Rights in collaboration with National College "Spiru Haret". Every year on December 12, National College "Spiru Haret" celebrates Graduation Day, an opportunity to bring together vesterday's and today's students of the College to have an interesting exchange of experience between generations. In 2014, the event was organized under the significant name: "Learning by means of projects: Socio-Activ-Spir education for human rights and the rights of the child". The project involved students from 11<sup>th</sup>, 10th and 9th grades - social sciences in educational activities related human rights. The objective was to create an educational framework stimulating cooperation and thus making possible and exchange of opinions on a hot topic in contemporary society: respect for human rights. These are activities to be listed as good educational practices;

• Conference on "Law and Administrative Justice from an Interdisciplinary Perspective", organized in partnership with the National School of Political and Administrative Studies and University Sakarya of Turkey.

### **III. ORGANIZATION OF SPECIFIC ACTIVITIES DEVOTED TO HUMAN RIGHTS**

Organization of seminars, symposia or roundtables, together with the Institute's other activities of research, education and training, make up a harmonious approach to human rights issues, reflecting the importance of their promotion and protection.

The reports and the studies presented on occasion of various events were the outcome of the research activity performed by the Romanian Institute for Human Rights. Whether events organized by the Institute alone (see Appendix A) or events organized in partnership, the exchange of experience, the opinions expressed and the conclusions drawn paved the way for approaching new research topics, finding new methods to deal with the various aspects related to training and educating in a spirit of respect for human rights.

The foreign fact that or domestic organizations and bodies taking interest in the field of human rights requested the Institute to participate with studies, presentations, reports, etc., in events they organized (see Appendix B) illustrates the good name the Institute enjoys both at national and at international level, a prestige gained through the rigour and the consistency with which the Institute got involved with the protection and the promotion of the fundamental freedoms and human rights.

It is worth mentioning that the Institute has constantly attracted in the events it organized participation and involvement of a large number of actors in the field of human rights from Parliament, the Government, governmental and non-governmental bodies, or international and regional organizations. By getting these actors involved, making them contribute with works, documents. presentations. dissertations or expertise or reports on behalf of the institutions and the organizations they represented, the endeavoured to achieve Institute better communication and closer collaboration for finding and implementing more effective solutions to improve the status of human rights in Romania.

The Romanian Institute for Human Rights organized a large number of meetings and

debates devoted to the assertion, the promotion and the protection of human rights (see **Appendix A**) attended by personalities in the field of human rights from Romania and from abroad.

## **Equal opportunities**

The year 2014 was marked by the adoption at governmental level of the second National Strategy for equal opportunities for women and men for the years 2014-2017 and its Action Plan. These documents were debated by the RIHR at the meetings devoted to this field, such as the Conference on "Women's rights and gender equality", organized on occasion of the International Women's Day in collaboration with the Romanian Association for the United Nations, the UNESCO Chair for Human Rights, Democracy, Peace and Tolerance, the Romanian Association for Women's Rights and the "Clubul de la Cheia" Association.

Also, the latest Report by the European Union Agency for Fundamental Rights on "Violence against Women in the European Union" was a good framework to organize important debates about how women's rights were promoted and respected in Romania. These debates were organized in collaboration with the National School of Political and Administrative Studies. Romanian the Association for Women's Rights, the Association for the Promotion of Family Rights "Family Forum" and the Romanian Independent League for the Rights of the Child and the Young.

It is also worth reminding the Conference on "Domestic violence and the national and the international instruments to prevent and combat it", organized in collaboration with the UNESCO Chair for Human Rights, Democracy, Peace and Tolerance and the "Clubul de la Cheia" Association.

#### **Non-Discrimination**

Art. 14 in the European Convention on the Defence of Human Rights and Fundamental Freedoms on prohibition of discrimination

points out that "the enjoyment of the rights and freedoms set forth in this Convention shall be secured without discrimination on any ground such as sex, race, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth or other status". In 2014, 20 after Romania vears had acceded the Convention. fight against discrimination. respect and promotion of the principle of non-discrimination were topical subjects approached by the Romanian Institute for Human Rights in collaboration with its partners such as the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies, the Commission on Human Rights and Minorities Issues in the Senate, the Foreign Affairs Commission in the Chamber of Deputies, the Institute for the Study of National Minorities Issues, the National Council for Combating Discrimination.

On occasion of the European Action Week against Racism, the Romanian Institute for Human Rights organized a number of events (seminars, debates, roundtables) and an ample awareness raising campaign for young students in schools and universities as well as in public institutions in Bucharest and in other cities. The debates referred to the importance of respect for diversity, particularly emphasizing on the increasing role of the socializing networks, which assist migrants and refugees by combating nationalism, racism and neofascism.

We should also remind of the International Conference "Non-Discrimination on and Equality of Opportunities - NEDES 2014", organized in partnership by Christian University "Dimitrie Cantemir" of Bucharest, the National Council for Combating Discrimination, the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies and with the participation of the Romanian Institute for Human Rights. The event gave specialists in the field of human rights the opportunity to analyze and discuss about the way the principle of non-discrimination and equality of opportunities are observed in the Romanian society and at international level. The debates dealt with such

topics as multiple discrimination and the fight against it. harassment theory and \_ jurisprudence. domestic violence and its consequences upon the psychic development of the children, the role of women in the process of emancipation, of fight against discrimination and promotion of the equality of opportunities principle, application of the equality of opportunities principle in the evaluation of the individual professional performance in the local public administration, etc.

At the same time, 2014 was the year when the European Commission against Racism and Intolerance issued its fourth report on Romania – a document that was analyzed in the framework of debates organized by the Romanian Institute for Human Rights in collaboration with the Romanian Association for the United Nations, the Romanian Association for Personal Freedom and Human Dignity, the Romanian Association for Women's Rights and the "Clubul de la Cheia" Association.

## **Rights of the child**

An important item on the Institute's agenda is the protection and the promotion of the rights of the child, while taking into account the provisions of the International Convention on the Rights of the Child and also the regional instruments on child adoption, fight against the trafficking in human beings, etc. In this respect, the Institute organized a number of events, debates and discussions both with representatives of public institutions having powers in the field and representatives of the academic world and non-governmental organizations, meeting that dealt with issues related to the improvement of the related legislation. the right to education, non-discrimination against certain categories of children.

The RIHR, in collaboration with the Sub-Commission on Equality of Treatment and Non-Discrimination and the Sub-Commission on Monitoring Observance of the Rights of Persons Deprived of Liberty, organized a debate on juvenile justice, getting insight about the latter's problems in the public area and promotion of the legislative reform and prevention of juvenile delinquency in Romania.

At the same time, the rights of the child was one of the main topics on the visiting agenda of Mr. Nils Mužinieks, Council of Europe Human Rights Commissioner.

Last but not least, the Institute, on request by the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies, submitted a number of viewpoints on the bills under debate by the Commission having an impact upon the promotion and the protection of the rights of the child. In this respect, we should remind the Bill on the child's personal health book and the Bill on establishing the child's electronic medical file<sup>4</sup>, and the Bill on School Medicine<sup>5</sup>.

#### Access to justice

Throughout the year 2014, the RIHR organized a number of conferences, seminars and debates dealing with access to justice as a fundamental right. Of these, the following should be particularly mentioned:

International The Conference on "Effectiveness of the legal norms – Challenges of the new decade", an event at its third edition, organized by the RIHR and the Faculty of Law University "Dimitrie Cantemir" of of Cluj-Napoca in collaboration with the Social and Humanist Research Department of History Institute "George Barițiu" of Cluj-Napoca, a Department of the Academy of Romania, the Romanian Association of Penal Sciences and other partners as well. The studies presented dealt with such topics as human rights education in higher education units, the role of the civil society for the consolidation of democracy, international law issues related to human rights, human rights and good the governance of justice, the legal expertise in terms of the new Criminal Procedure Code, the protection of juveniles according to the Romanian legislation, the legal status of the workday, the role of the prosecutor according to the Criminal Procedure Code, the rights of persons with disabilities in the European Union, etc. Also, two workshops

were organized in the framework of the Conference, which dealt with such topics as: special surveillance and investigation techniques, and present-day trends in the legal education.

The annual Conference with international participation on "Justice and the administrative law from an interdisciplinary point of view", organized in partnership with the National School of Political and Administrative Studies and University Sakarya of Turkey, a scientific event whose purpose was to provide new scientific research topics for specialists in law and administrative sciences and also to disseminate the results of the researches achieved so far to improve the quality governance. The researches presented and the debates that followed referred to aspects related to administrative judicial pronouncements, the influence of human rights upon the law, migration and the law, globalization and sustainable development, new frontiers in criminal justice, as well as the future administrative configuration and the law.

Representatives of the RIHR participated in the International Conference on "The national law between harmonization and euro-compatibility", organized by the Law and Public Administration Department of the Juridical Faculty of Economic, and Administrative Sciences, University "Petru Maior" of Tg. Mures in partnership with the RIHR. The participants in the event analyzed aspects related to the evolution and the trends in Law and public administration at national, European and even international levels with emphasis on the relationship between the European institutions and the national ones in the efforts to harmonize and adapt to the changes in the field, as well as the need for a reform of the legal and the administrative system.

In its capacity as observer member of the European Law Institute (ELI), the Institute's representatives participated in the ELI annual Conference organized in partnership with the Faculty of Law of the University of Zagreb, making their contribution to the debates on such topics as: the correct application of human

rights in Europe, the relationship between the national courts and the supranational courts in the European legal order. At the same time, the participants were presented a number of projects on transnational principles with the European civil procedure norms or *how to prevent and solve competency conflicts in the criminal law*.

Also, the Institute was invited to submit a number of viewpoints in the field of justice, of which it is worth mentioning the Viewpoint on the Bill on ratification of Protocol 15 to the European Convention on Human Rights<sup>6</sup>, formulated on request by the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies.

The RIHR, in its capacity as member of Legal Working Group of the European Network of National Human Rights Institutions, participated actively both in the discussions devoted to the reform of the European Court of Human Rights, promotion of the European Convention on Human Rights and of the Charter of Fundamental Rights of the European Union, and the elaboration and presentation of the Group's proposals related to interventions as third parties in the cases pending before the Court of Strasbourg.

Project "CLARITY", achieved by the European Union Agency for Fundamental Rights in partnership with 12 national human rights institutions from Member States of the European Union<sup>7</sup>, including Romania through the RIHR, has the purpose to offer better knowledge about non-judicial bodies (national human rights institutions, equality bodies and Ombudsman-like institutions), which may be of assistance to the victims when their rights are violated.

At the same time, the Project is intended to create an online instrument for easy identification of those non-judicial bodies with powers in the field of human rights that are most suited for a certain category of fundamental rights. The online instrument is going to cover various fields related to human rights, including the one referring to discrimination.

This instrument is also meant to offer information about how a petition should be filed or where the victims may receive assistance.

## Family

The year 2014 marked the 20<sup>th</sup> anniversary of the International Year of the Family, on which occasion the main directions of the family policy strategy were established both at the level of the United Nations, through its Department of Economic and Social Affairs, and at the level of the European Union and the Organisation for Economic Co-operation and Development (OECD). In this context, the RIHR set out to promote and consolidate family supporting policies, as well as intensify its research activities in the field, to make a contribution to and assist the Government in the elaboration of family-related public policies, essential for combating and preventing poverty and social exclusion and, also, fundamental to prevent family marginalization.

Out of the activities achieved for the promotion of the European Year of Reconciling Work and Family Life and the International Day of Families<sup>8</sup> mention should be made of the debate on "Opportunities and obstacles against reconciling work and family life", organized in collaboration with the Romanian Association for the United Nations, the Association for the Promotion of Family Rights, Family Forum, the "Clubul de la Cheia" Association, the Romanian Association for Women's Rights and the Romanian Association for Personal Freedom and Human Dignity, which pointed out the importance of the family within the society and its development. At the same time, the event was an opportunity to discuss how the family – the basic nucleus of society – is affected by the social and the economic changes, how these

extremely important nuclei for the progress of the entire Romanian society can be consolidated. The participants in the conference also discussed the national but also the European policies and programmes meant to reconcile work and family life as well as ways to promote the best practices in the field.

#### Combating trafficking in human beings

Based on the international as well as European provisions in such documents as the Convention for the Suppression of the Traffic in Persons and of the Exploitation of the Prostitution of Others, the United Nations Convention against Transnational Organized Crime, and the Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children, as well as the European Convention on Action against Trafficking in Human Beings, the EU Strategy towards the Eradication of Trafficking in Human Beings (2012–2016), the Romanian Institute for Human Rights continued the series of researches and debates with representatives of specialized governmental institutions, of the legislative, and also of the civil society.

In this respect, it is worth mentioning the meeting on "Trafficking in persons and forced prostitution in Europe", organized by the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies with the participation of a delegation of the Commission for Human Rights and Humanitarian Aid in the Bundestag, members of the Commission on Human Rights and Minorities Issues in the Senate and representatives of the Romanian Institute for Human Rights. The discussions referred to the evolution of the related legislation in Romania and the impact upon the Roma community. On occasion. the Institute presented the international and the national legislative framework, pointing out the progress achieved in terms of preventing and combating the trafficking in persons, while also emphasizing on the importance of improving the quality of the protection and the assistance for the victims, as well as attraction of the civil society in preventing and combating the phenomenon.

Likewise, it is worth mentioning the symposium on "The national, the regional and the universal legislations on preventing and combating trafficking in persons", organized by the Romanian Institute for Human Rights in collaboration with the Romanian Association for the United Nations on occasion of the 60<sup>th</sup> anniversary of Romania's accession to the Convention for the Suppression of the Traffic in Persons and of the Exploitation of the Prostitution of Others.

## Migration

In 2014, the Romanian Institute for Human Rights was requested by the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies to submit a number of viewpoints on the bills under debate by the Commission referring to issues related to asylum, migration and citizenship. Thus, we should mention the Bill approving on Government Ordinance 1/2014 No. on amending and supplementing Law No. asylum 122/2006 on in Romania and Government Ordinance No.44/2006 on the social integration of foreigners who obtained a form of protection or the right to reside in Romania<sup>9</sup>. Taking into account the characteristic features and the trends of the migration phenomenon and the profoundly humanitarian nature of the actions that have to be taken to provide protection to the persons applying for international protection, the RIHR appreciated as absolutely necessary and welcomed the modification and the supplementation of Law No. 122/2006 on asylum in Romania under Ordinance No. 1/2014 as a logical result of harmonizing the domestic legislation with the obligations assumed on adherence to the European Union's regulations.

As regards the Bill on amending art. 11 in the Citizenship Act No. 21/1991, republished<sup>10</sup>, introducing a provision in the Romanian legislation by virtue of which Romanian ethnics would enjoy preferential treatment for obtaining the Romanian citizenship would mean to enact a discriminatory procedure for obtaining the

Romanian citizenship, in terms of the ethnic origin, which infringes upon art. 5 in the European Convention on Citizenship. Such a regulation had better refer to Law No. 299/2007 on assistance given to Romanians from everywhere, whereas Law No. 21/1991 regulates the juridical link between Romania and the person who applies for the Romanian citizenship.

It is worth mentioning that the researches achieved by the Institute were the main source for the national Report on *Migration and Law*, presented by the RIHR's representatives at the 19<sup>th</sup> Congress of the International Academy of Comparative Law of Vienna, 2014.

## **Right to health**

The Romanian Institute for Human Rights (RIHR), in partnership with the Romanian Association for the United Nations (ANUROM) and the Infoeuropa Centre in the Ministry of Foreign Affairs and with the participation of the representatives of the Commission on Human Rights, Cults and National Minorities Issues in the Chamber of Deputies and the Commission on Environment and Ecological Balance in the Chamber of Deputies, organized a debate on "World Health Day - the right to health". The participants in the event were presented several dissertations on hot topics in the field: ecologization and the fight against pollution desiderata for the globalization of health, education for health, the guarantee of the children's right to health in Romania, the migrants' right to health, etc. At the same time, the discussions pointed out the importance of reducing inequalities in the field of health and the need for finding a balance between financing and healthcare.

Also, on occasion of World Water Day, the RIHR organized a debate on "Clean water for a healthy world" dealing with such issues as the relationship between man and life, between access to water and the health of an individual, a family, a community or a society, vital elements for the development of a nation. The participants pointed out the need to ensure a quantitative and a qualitative protection of waters, as well as the role, the duties and the responsibilities of those having with maintaining, exploiting and protecting water sources. The event was achieved in collaboration with the Romanian Association for the United Nations (ANUROM) and the "Clubul de la Cheia" Association.

## Persons with disabilities

The Romanian Institute for Human Rights, in its capacity as independent mechanism for promoting, protecting and monitoring the Convention on the Rights of Persons with Disabilities, according to art. 33.2 of CRPD<sup>11</sup>, is committed to maintain a permanent dialogue both with the governmental institutions having powers in the field and the civil society, so that it might be able to analyze objectively the way the provisions of the Convention are reflected by the national legislation, the way these persons' rights are observed, as well as the level of awareness about and understanding of the notion of disability.

The working visit to Romania of the Council of Europe Commissioner for Human Rights was an important moment for promotion and protection of the rights of persons with disabilities was one of the major topics approached by the representatives of the RIHR and the Commissioner. On the occasion, the participants debated aspects related to the right to live independently and be included within the community, the situation of persons with disabilities living in institutions, the right to the acknowledgement of their legal capacity, the right to inclusive education, as well as the legal and the institutional framework for the protection of the rights of persons with disabilities.<sup>12</sup> The discussions were based on the most recent report of the RIHR on the Evolution of the protection and the promotion of the rights of persons with disabilities in Romania, the Commissioner appreciating the Institute's interest in these topics, as well as the

institutional effort. On the occasion, the Council of Europe representative pointed out the importance of ensuring adequate human and financial resources for the Institute to be able to fulfil its mandate.<sup>13</sup>

The importance of adopting a national strategy in the field of disability, with the elaboration of which the civil society should also be involved, particularly persons with disabilities and the organizations representing them and which should take into account the provisions of the CRPD was pointed out on occasion of a debate on Rights and a high quality life for persons with the Down syndrome, organized by the RIHR. The participants pointed out the need to (re)define the purpose of the social policies in the field, in compliance with the provisions of the Convention, to amend/supplement art. 50 in the Constitution of Romania and art. 1 in Law No. 448/2006 on the protection and the promotion of the rights of persons with disabilities.

In the framework of Project "Gaining about awareness autism", the RIHR in collaboration with the UNESCO Chair for Rights. Human Democracy, Peace and Tolerance and the Romanian Association for the United Nations (ANUROM) organized a debate on the rights of persons with autism in Romania, an event which took place on occasion of the World Autism Awareness Day. The participants included representatives of the civil society, the Ministry of Labour, Family, Social Protection and Elderly, representatives of the university teaching staff, researchers, candidates for a Doctor's Degree and candidates for a Master's Degree. The discussions focused on such issues as acknowledgement of the legal capacity of persons with disabilities - implying, on the one hand, provision of adapted legal services as part of the social policies in the field to provide equal opportunities in terms of legal assistance and, on the other hand, modification of the civil legislation so that it might be able to provide acknowledgement of the legal capacity of persons with disabilities -, the equal right of persons with disabilities to possess or inherit

properties, to manage their own incomes and have access to bank loans, mortgages and other forms of financial crediting. The participants also pointed out the importance of respecting the right of persons with disabilities to make a family - the Civil Code in effect prohibiting marriage to the mentally alienated or the mentally defective, no matter whether they are placed under interdiction or not, who are not allowed to get married not even in their moments of temporary lucidity. As far as the education was concerned. right to the discussions primarily pointed out the need that the specific legislation should include a definition of the "inclusive education" concept and give up the syntagma "integrated special education".

On occasion of the Autism Spectrum Disorders (ASD) Day, the Romanian Institute for Human Rights organized a debate on the protection and the promotion of the rights of these persons in Romania, an event achieved in collaboration with the Sub-Commission on Equality of Treatment and Non-Discrimination and the Sub-Commission on Monitoring Observance of the Rights of Persons Deprived of Liberty. The discussions focused on the elaboration of a national strategy corresponding to the needs of persons diagnosed with autism spectrum disorders and institution of a complex legal framework in support of this area. They also revealed the need to elaborate regulations in the field regarding the development of the diagnosing services for persons with ASD, provision of access to professional training services and the access of adults with ASD to the adapted labour market, as well as increased social integration of these persons.

The International Day of Persons with Disabilities was also an opportunity for the Institute to organize a roundtable bringing together representatives of the civil society, members of the university teaching staff, researchers and practitioners. The discussions referred to such issues as taking advantage of the power of technology to promote inclusion and accessibility, achieving full and equal participation of persons with disabilities in the social life.

In the year 2014, the Institute, by the researches, the events and the debates it organized or in which it participated. emphasized on the importance of developing the legislative framework in the field of disability, so that it might allow persons with disabilities to obtain and maintain maximum autonomy, de fully develop the physical, mental, social and professional capability and achieve full integration and participation in all aspects of life.<sup>14</sup> At the same time, the discussions pointed out the need to organize, consolidate and extend complex habilitation and rehabilitation programmes, particularly in such fields as health, employment, education and social services, so that these programmes might start early as possible, be based on a as multidisciplinary evaluation of the individual needs and abilities, and support participation and integration in the community in all social aspects, on the basis of freely expressed consent, while being available as close as possible to the community where these persons live, including rural areas.<sup>15</sup>

The RIHR is member of the Group for the implementation of the Convention in the framework of the European Network of National Human Rights Institutions in the United Nations system, while also being the only institution in our country assigned to participate in the Working Forums organized every year by the European Commission with regard to the implementation of art. 33 in the UN Convention.

## **Rights of elderly persons**

In its activities, the RIHR dealt with and analyzed such topics as social rights, promotion of active ageing, promotion of solidarity between generations and dignity of all people by combating poverty and social exclusion.

Also, protection of the rights of elderly persons and long term caretaking is a topic of interest, the Institute participating in a Project achieved by the European Network of National Human Rights Institutions (ENNHRI), whose

member it is, and the European Commission through its Directorate-General Employment, Social Affairs and Inclusion. The Project is intended to determine in Europe an approach to elderly caretaking from the point of view of human rights, clarify the international and the regional standards applicable in the field and make recommendations to the decision-makers in Europe to optimize the protection of these persons, as well as acknowledgement of the increasing role of national human rights institutions. Thus, in 2014, the Institute participated in a number of meetings and discussions regarding analysis and establishment of the purpose, the stages and the methodology of the Project, for it is member of both the Advisory Committee and the Pilot Group.

Finally, it is worth mentioning the debate on "The fundamental human right of elderly persons to medical, sanitary and social protection, organized by the Romanian Institute for Human Rights in collaboration with the Romanian Association for the Rights of Older Persons (ARDOVT) and the Romanian Association for the United Nations (ANUROM) on occasion of the International Day of Older Persons.

## Business and human rights

The RIHR's researches in the field were continued in 2014, for this is a topical issue at both national and European level. The Institute's analyses and debates were based on the most important international documents: the United Nations General Principles, the European Union Corporate Social Responsibility Strategy, the Action Plan of the European Network of National Human Rights Institutions, etc.

An example is the debates organized by the Institute in collaboration with the Romanian Association for the United Nations (ANUROM) on the importance of adopting a national action plan showing the priorities and the actions to be taken by the Romanian State in support of the implementation of the international and the regional obligations and commitments in the field. The Plan should reflect such principles as the State's duty to observe human rights, the

corporate responsibility to observe human rights, and access to effective redress in case of human rights violations.

Also, the Institute, in its capacity as national institution acknowledged in the United Nations system, participated in a number of debates organized by the Office of the High Commissioner for Human Rights, one of which was the United Nations Annual Forum on Business and Human Rights. The main topics referred to the strengthening of public policies in the field by means of national action plans, financial sector and human the rights, improvement of the reporting system in the field of human rights, cooperation between national human rights institutions, the importance of human rights education, public acquisitions and human rights, etc.

# The international mechanism of universal periodic review (UPR)

Taking into account the recommendations by the United Nations Human Rights Council<sup>16</sup> as a result of the Country Report<sup>17</sup> on occasion of the second evaluation cycle – UPR of 2013, the Romanian Institute for Human Rights undertook both informing public institutions and the civil society about them and achieving the necessary steps to implement the.

In this respect, in the year 2014 the Institute organized a number of meetings and debates alongside with representatives of governmental institutions, of various public institutions with powers in the field of human rights and representatives of non-governmental organizations.

# Network of national human rights institutions

The role of the Romanian Institute for Human Rights, acknowledged at international and European level, was also pointed out in the Report by the United Nations Committee on Economic, Social and Cultural Rights, following an analysis of the Country Periodic Report.<sup>18</sup> In this respect, the Committee pointed out the importance of having an independent and efficient national institution in the promotion and the protection of human rights, in compliance with the Paris Principles.<sup>19</sup>

In the framework of the Conference on "Implementation of the international human rights commitments in the national realities: the contribution of Parliaments in the activity of the United Nations Human Rights Council", organized on initiative by the Foreign Policy Commission in the Chamber of Deputies by the Chamber of Deputies in collaboration with the Inter-Parliamentary Union, the Director of the RIHR pointed out the important role of national human rights institutions both at national level, as bridges between the institutions of the State governed by the rule of law and the civil society, with reference to the Principles of Belgrade on the relationship between national human rights institutions and adopted in Parliaments, 2012, and at international level, through the important contribution in the universal periodic review process, particularly beginning with the second cycle, as well as the resolutions adopted by the Human Rights Council, one of the most recent being Resolution20/14 of July 2012.<sup>20</sup>

### IV. PUBLICATION OF REGULATIONS, DOCUMENTS, STUDIES AND RESEARCHES IN THE FIELD OF HUMAN RIGHTS

The Romanian Institute for Human Rights promotes training and information in the field of human rights for the benefit of public bodies, non-governmental organizations and natural persons, in relation to respecting, protecting and guaranteeing human rights through domestic and international regulations, institutions and mechanisms, practices and customs. It assumes the role to inform all those interested about the most recent researches in the field of human rights, the international commitments assumed by Romania and the way they are accomplished. The Institute translates publishes and international documents which, by their topical nature, should be known by governmental and non-governmental institutions for the promotion and the protection of human rights.

## **Periodic publications**

A) The quarterly "Drepturile Omului" publishes reports, studies, researches and articles. It also publishes texts, national or international regulations of major significance in the field of human rights, the related jurisprudence of the European Court of Human Rights and/or the national courts, notes, comments or book reviews.

The topics approached include a scientific and diversified analysis of the fundamental freedoms and human rights, with emphasis on the collaboration relations and the relationship with the values, the principles, the norms and the standards governing the institutions and the mechanisms, as well as on the terms, the concepts and the methodological and technological trends. These are added the reporting of various events in the field of human rights, book reviews in the field of human rights, the Institute's latest publications and brief presentations of the main activities organized or attended by the Romanian Institute for Human Rights.

**B)** Info IRDO, the monthly information bulletin for the public, briefly presents the latest news about domestic and international human rights events, studies and scientific researches. The bulletin also presents various cases brought before the European Court of Human Rights and the Court of Justice of the European Union, in an attempt to meet the present needs of the civil society, of institutions, students, etc. It is also worth mentioning the columns devoted to recently adopted international documents.

## **Researches volumes achieved in 2014**

## • Drepturi egale și mediu accesibil<sup>21</sup>

The volume renders the interest the United Nations has taken in the last decades to sustain the efforts of persons with disabilities who have become increasingly active to assert their strength and confidence in their own abilities to live and independent life. The change of attitude towards disability started in the 1970s with the adoption of the *Declaration on the Rights of Mentally Retarded Persons (1971)* and the *Declaration on the Rights of Disabled Persons* (1975), documents that paved the way for the future complete sets of principles, which would eventually entail the social integration of persons with disabilities.

The development of the Standard Rules on the Equalization of Opportunities for Persons with Disabilities (1993), a document elaborated as a result of the experience accumulated during the United Nations Decade of Disabled Persons, brought along an important point of view shift, from social protection to rights granted to persons with disabilities globally.

The most recent United Nations document, the Convention on the Rights of Persons with Disabilities (2006), marks the beginning of a new stage in the efforts to promote, to protect and provide full and equal exercise of all human rights and fundamental freedoms by all persons with disabilities, as well as to promote the respect for their intrinsic dignity.

The volume also presents several cases form the jurisprudence of the European Court of Human Rights related to persons with disabilities, cases where the Romanian State is a party, which won the authors' attention particularly for the diversity of the articles under whose sphere of application they fall.

The volume is a collection of instruments regarding the rights of persons with disabilities

and related jurisprudence, which may prove helpful to authorities when they elaborate policies and take legal measures in the field of disability.

## • Migration and Law

The study is focused on a topic that will always be hot as long as there are discrepancies in terms of welfare between the various regions of the world.

By the recent reforms that were necessary to achieve legislative harmonization after Romania became a Member State of the European Union, State provided fair treatment the and harmonious integration of aliens in the Romanian society. Thus, substantial changes were introduced in the norms regulating the status of aliens in Romania in their capacity as citizens of Member States of the European Union and the European Economic Area, as well as the rules governing asylum in Romania in order to ensure conformity with the international and the regional instruments where the Romanian State is a party.

Modifying the national legislation in the fields mentioned above, the law makers tried to eliminate once and for all any possible failure in the implementation of the legislative framework regarding the status of aliens on the territory of Romania.

# • Rights of Persons with Disabilities in Romania. Recent Developments

The study, achieved by the Romanian Institute for Human Rights (RIHR) in its capacity as independent mechanism monitoring implementation of the Convention on the Rights of Persons with Disabilities, is a continuation of the research achieved in the year 2013, including both new research elements and recent statistic data.

The amplitude of the Convention and the wide range of issues it approaches make monitoring and implementing it more challenging than in the case of most other conventions.

The volume emphasizes on a number of issues that need the immediate attention of decision makers, such as adoption of a national strategy and an action plan promoting a consolidated and long-term detailed vision, with measurable priorities and results, to improve the life of persons with disabilities; increased awareness about and understanding of disability; accessibility, meaning that all policies, programmes, standards and services should be developed taking into account the ordinary needs of persons with disabilities.

At the same time, there is need for more assistance services and support, multidisciplinary, integrated, accessible and well regulated services, which should enable persons with disabilities live an independent life and participate in the economic, social and cultural life of their communities.

Another important element is research, which is essential for increasing the public's understanding of disability related issues. This however involves investment in human capacity, to develop a group of researchers specialized in the field of disability.

## • Drepturile copilului – 365<sup>22</sup>

The rights of the child, consecrated and guaranteed by international and domestic regulations, may be generally grouped into *rights of protection* against any forms of physical or emotional abuse, *rights of development*, closely related to the necessary services, such as education and healthcare, and all children's access to these rights, and *rights of participation and consultation* in relation to the decisions affecting them.

Romania, in its capacity as a party to the United Nations Convention on the Rights of the Child and its Protocols as well as a party to the regional treaties in the field, took significant efforts to harmonized the domestic legislation with the principles and the norms assumed through its international commitments.

Once the amendments to Law No. 272/2004 on the promotion and the protection of the rights of the child were adopted, the principle of the best interests of the child has become significantly more visible in the national legislation. Thus, the entire legislative package adopted by Parliament of Romania, as well as the strategies and the measures for the application of these regulations, fully cover these rights.

The volume is based on a whole series of publications issued by the Romanian Institute for Human Rights including such volumes as

"Drepturile copilului. Drepturile mele"<sup>23</sup>, "Drepturile copilului"<sup>24</sup>, "Principalele instrumente internaționale privind drepturile omului la care România este parte"<sup>25</sup>, etc., achieved with the contribution of the Institute's researchers.

# • Promovarea și protecția drepturilor omului de către administrația publică<sup>26</sup>

The study attempts to identify and point out the levers and the mechanisms for the promotion and the protection of human rights at the level of the public authorities, while at the same time find solutions to stop the latter violate these rights.

Starting from the most important documents regulating human rights at international and at European level, as well as the organizations that promoted them, the study analyzes such as good governing and good concepts governance, the role of the legislative power in terms of the actions it takes to promote and to protect human rights at national level in its relationship with the public administration authorities. The study also makes an analysis of the entire set of institutions and authorities that achieve justice in Romania, with emphasis on the powers each of them has as well as the vulnerability of the judiciary system in face of corruption.

As far as the role of the executive and of the public administration authorities is concerned, a significant role for the protection of the citizens' rights is that of certain authorities or bodies established at central level, with coordinating and controlling, including jurisdictional powers, independent from the government and even from the head of the State.

## • Administrația parlamentară. Drepturile și obligațiile funcționarilor publici parlamentari<sup>27</sup>

The research deals with aspects related to the human resources of this type of administration, the analysis being made in terms of parliamentary public servants, the rights, the duties and the responsibility they have following harmonization of our legislation with the European aquis and also, necessarily, in terms of observing human rights in the field.

The study analyzes the status of the parliamentary public servant as compared to similar regulations in European countries with parliamentary tradition and to the statutory regulations related to a new category of servants at the level of the European Union. Adoption of a special status should be accompanied by a guarantee for its application, as well as the observance of parliamentary autonomy. At the same time, the independency status and the specificity of parliamentary activity should not limit the parliamentary public servant in the exercise of his/her powers and thus adopt a bureaucratic model in the fulfilment of his/her duties.

The volume also includes general aspects related to the parliamentary administration with emphasis on both the political leading structure and the administrative hierarchic one, pointing out the connection between the public administration and the democracy of the state governed by the rule of law as well as the role and the functions of political parties in a state governed by the rule of law.

## • Ministerul Public. Organizare, administrare și relația cu societatea civilă<sup>28</sup>

The study analyzes the importance and the role of the Public Ministry in promoting and guaranteeing the observance of the citizens' fundamental rights and freedoms in a democratic society, in a State governed by the rule of law. It identifies and analyzes the relevant normative framework that defines the role of this institution, identifies the evolution of the concept of civil society along history, analyzes the citizen's rights in the relationship with the Public Ministry and shows the role of the civil society in protecting and guaranteeing these rights.

The volume includes a number of recommendations regarding the organization and the administration of the Public Ministry in Romania, in terms of guaranteeing the fundamental rights and freedoms. In this

respect, it identifies and analyzes the most relevant vulnerabilities found at the level of the Public Ministry institution, such as the authority of the Ministry of Justice upon the Public Ministry, the pressure exerted upon prosecutors, the access to various positions, professional training, the corruption phenomenon, the system of the prosecutor's protection against the citizens' reprisals, etc.

## V. THE CENTRE OF DOCUMENTATION

According to its mandate, the Romanian Institute for Human Rights is tasked to maintain and run a documentation centre. By means of its library, the Centre makes available to all users documentation in such fields as law, human rights, international conventions and covenants, legal texts, studies, bibliographic publications and references, as well as volumes dealing with topics from various related fields.

The library has a book collection structured in over 251 research fields. The Romanian Institute for Human Rights was the beneficiary of a large number of publications in the form of donations from international organizations, higher education institutions, NGOs as well as institutions having similar preoccupations as the RIHR.

As part of its information and documentation activity, the RIHR paid special attention to partnerships and collaborations with national and specialized institutions from other countries. or belonging to international organizations in the field such as: the European Union Agency for Fundamental Rights (FRA), the Alexandrina Library - Alexandria, Egypt, Library of the Swiss Institute the of Comparative Law - Lausanne, Switzerland, the European Law Institute, the University of Leicester Library, Great Britain, the Library of the International Institute of Law of French Expression and Inspiration, the International Academy of Comparative Law (IACL), the Library of the Faculty of Law of the University of Strasbourg, France, the Library of the Catholic university of Louvain, Belgium, the

Library of the University of Potsdam, Germany, the Library of the University of Padua, Italy, the Library of the University of Luxemburg, the Library of the University of European Studies in the Moldova Republic, the Library of the Norwegian Centre for Human Rights, the Human Rights Centre in Finland, the Parliamentary Ombudsman of Finland.

Partnerships consisting of exchanges of publications and correspondence were also initiated with the Library of Congress in Washington DC, USA, the National Library of the Czech Republic, the National Library of Madrid, Spain, and the National Library of Vienna, Austria.

Equally important, the Institute's Documentation Centre keeps permanent contact with the county libraries in our country to which it sends alongside with the quarterly "Drepturile Omului" the most recent publications issued by the Institute.

The RIHR's publications have also been requested by the ministries having powers and preoccupations in the field of human rights, prefect's offices, local councils, teachers' training centres, courts of appeal, courts, tribunals, the General Parquet. The Documentation Centre readily answered to all these requests.

Constantly preoccupied to provide information and documentation about the Institute's and its partners' scientific activity, the Documentation Centre sent free of charge the publications issued in the year 2014 to all national applicants: the Central University

Library, the National Library of Romania, the Metropolitan Library, the Academy of Romania, the Senate of Romania, the Chamber of Deputies, the Constitutional Court, the Superior Council of Magistracy, the High Court of Cassation and Justice, the Legislative Council, the Government of Romania, the Legal Research Institute of the Romanian Academy, the National Institute of Magistracy, the National School of Clerks, the National Institute for the Training of Lawyers, the National Council of SANITAS Federation, the Ministry of Labour, Family, Social Protection and Elderly, the "Dimitrie Cantemir" Ecological University, the National School of Political and Administrative Studies, the "Ovidiu" University, the "Alexandru Ioan Cuza" University, the UNESCO Chair for Human Rights, Democracy, Peace and Tolerance of the North University of Baia Mare, etc.

There also were international organizations and institutions who were interested in receiving and did receive free of charge the Institute's publications issued in 2013 and 2014: UNDP, UNESCO, UNICEF, UNCHR, the Council of Europe, the European Court of Human Rights, the European Social Charter Secretariat, the European Court of Justice, the Office of the United Nations High Commissioner for Human Rights in Geneva, the International Academy of Comparative Law, the Centre for International and European Studies, the European Union Agency for Fundamental Rights. the Parliamentary Ombudsman of Finland, the Human Rights Centre in Finland, the European Law Institute, the International Institute of Law of French Expression and Inspiration.

Throughout the year 2014, the RIHR Documentation Centre was attended by a large number of readers (1700), scientific researchers, teachers, magistrates, lawyers, candidates for a Doctor's Degree, students, representatives of the civil society in Romania and from abroad who were interested in the scientific literature in the field of human rights or related fields. The number of readers has been considerably increasing from one year to another, while the collection of books was enriched by acquisition of a number of publications that assist the comparative study of several disciplines in terms of human rights.

The Institute webpage, established in 2007<sup>29</sup>, hosts a virtual library that includes most of the publications issued by the RIHR. The website has so far been accessed by approximately 3.5 million visitors and offers information about the Institute's activity and also, in terms of jurisprudence, about cases involving Romania brought before the European Court of Human Rights.

### **Public relations**

The entire activity of the Romanian Institute for Human Rights reflects the professionalism with which the Institute commits itself to the promotion and the respect of human rights. The Institute contributes to the protection and the observance of human rights and to deeper awareness about these at national, regional and international level through all its work of disseminating information, through all its activity, by means of debates and roundtables, conferences and symposia organized in collaboration with national institutions and the civil society.

At the same time, the RIHR was contacted throughout the year 2014 by large categories of persons, citizens from all over the country who addressed the Institute with numerous problems claiming violation of their rights, asking for clarifications or advice for resolution, either by means of the complaint filing mechanism, or applying for advisory opinion by telephone regarding the procedure of filing formal complaints or petitions to authorities to inform them about the violation of their rights. Throughout the year 2014, the RIHR took efforts to clarify and advise for the correct resolution of numerous such applications for legal advisory opinion, written statements, complaints, telephone calls.

The most frequent issues were violations of the right to property, refusal to execute a possession order for certain pieces of land, non-execution of judicial orders, complaints regarding pollution of the environment or violation of the norms related to the right to a healthy environment, violations of the labour legislation, complaints by natural persons regarding the progress of a trial or violation of the reasonable time constraints. There also were complaints referring to the execution of

sentence in penitentiaries, petitions related to the violation of the equality of opportunities principle, the violation of the rights of persons belonging to national minorities or religious denominations; complaints related to the incapacity of competent authorities to pay partially or totally certain financial rights derived from the social protection legislation (the financial assistance for various disadvantaged categories, recalculation of the pension, the children's allowance, etc.).

Both persons who came in person to the Institute's headquarters and those who contacted the Institute by phone received advisory opinions and guidance. Those who requested documentation were provided with the legal texts in effect and pertaining to the case. In approximately 70% of the cases registered by means of written petitions we were able to assist the petitioners guiding them to the competent body or making a recommendation regarding the institution to which he/she should apply. Most petitions were sent over to the institutions and the bodies authorized to solve the respective problem or application, including: the Ministry of Justice, the National Authority for Property Restitution, the Superior Council of Magistracy, the Advocate of the People, the Ministry of Labour, Family, Social Protection and Elderly, the Public Ministry, prefect's offices, local councils, mayor's offices, penitentiary directorates.

Expertise in human rights issues, the activity deeply committed to the protection and the observance of human rights, the fruitful collaboration with national and international institutions contributed to the increasing prestige of the RIHR among its beneficiaries and the similar institutions in Romania and from abroad.

As a result, many domestic and international bodies expressed their wish that the Romanian Institute for Human Rights, through its representatives, should be represented in their working structures or the managing structures. Here are a few examples: the RIHR is member of the UNESCO National Commission of Bioethics; member of the National Steering Committee of the United Nations Decade of Education for Sustainable Development.

At the same time, the Romanian Institute for Human Rights continued its activity in the framework of various international structures. As an international recognition of the efforts taken by the RIHR for the promotion of human rights, the latter or its representatives have been elected in various structures of such international bodies as: the European Network of National Human Rights Institutions (ENNHRI): member of the francophone Network of National Human Rights Institutions; member of the Steering Committee of the International Institute of Law of French Expression and Inspiration (IDEF); member of the International Union of Family Organizations; RIHR researchers are members of the working groups of the ENNHRI and some of them were designated experts with UNESCO, OSCE, the Council of Europe and the European Union, participating in this capacity as rapporteurs or section moderators in the framework of events devoted to human rights; as far as the human rights education activity performed by the Romanian Institute for Human Rights is concerned, an international recognition is the fact that, in time, the Institute was given several international awards.
